October 5, 2017

The meeting was called to order at 7:00 p.m. by the President, Marcel (W1MLD) with salute to the flag. The roll was called with 18 members and 0 guests present. A moment of silence was observed for those affected by the recent attack in Las Vegas.

A motion was made and seconded to accept the petition as written to continue in accordance with the bylaws to make changes in the bylaws. After a vote, the motion carried with 1 opposed. After further discussion a motion was made and seconded to withdraw the first motion and present at the next business meeting adding Associate Member status. After a vote, the motion carried with 1 opposed.

A motion was made, seconded and unanimously voted to adjourn at 8:20 p.m.
