## BUSINESS MEETING MINUTES

Thursday, January 11, 2018

### SECRETARY'S REPORT

A motion was made, seconded and voted to dispense reading of the Thursday, December 7, 2017 business meeting minutes and to accept the report as posted.

### TREASURER'S REPORT

SEMARA Treasurer, Michael J. McDonald, KB1NB reported total assets of \$79,972.91 with total inflows of \$140.00 and total outflows of \$2,648.94. As of Monday, January 1, 2018, the NETCOM balance was \$34,169.61 including annual taxes. Three checks were since received totaling \$13,430 yielding a new balance of \$20,739.61. A motion was made, seconded and voted to refer to audit.
