### OLD BUSINESS

Marcel L. Dumont, W1MLD brought up that Michael J. McDonald, KB1NB had wrote a letter regarding some additional revisions to the proposal submitted last month to our Constitution and Bylaws. Mike spoke toward this and mentioned that it would be great to get it right the first time. After a brief discussion amongst the membership, Richard J. Cabral, W1RJC agreed with the revisions and recommended to the membership that we vote together to defeat the current proposal that he presented last month. At a future business meeting, a fresh new proposal including some retooling and the revisions may be presented under new business.

The proposed modifications to our Constitution and Bylaws, which was presented at the May 2018 business meeting by Richard J. Cabral, W1RJC and four other life members in good standing, was voted on and defeated.

### NEW BUSINESS

Joseph E. Krisnosky, Jr., N1IXC announced he would be resigning from the Scholarship committee due to personal reasons.

Donald A. Rosinha, II, WA1BXY announced that Field Day 2018 will be conducted on the club's grounds this year. We will be operating as a 2E station on emergency power. We need some nighttime CW and SSB operators. Don is planning on operating a Get On The Air (GOTA) station, where non-licensed and technicians can also operate. He will be bringing his grill for a selection of burgers, hot dogs and beverages, with soda being stocked up in the refrigerator. He is planning to be staffed the entire 24 hours from 2:00 PM on Saturday until 2:00 PM on Sunday. His wife will be running SSB, but she is unable to do an all-nighter. The goal is to get at least 2,500 and Don would like anyone interested in participating to email. It was also noted that a generator will still be needed.

Armand F. Augustine, W1BUG made a motion that was seconded and carried to allocate \$100 for field day expenses including food, drinks and generator fuel.

Joseph E. Krisnosky, Jr., N1IXC made a motion that was seconded and carried that any expenditures exceeding \$100 must first be reviewed by the finance committee prior to approval by the membership. It was noted that this practice was voted into place several years ago and that this motion is to refresh and renew that procedure.

### FOR THE GOOD OF THE ASSOCIATION

Marcel L. Dumont, W1MLD mentioned that Donald A. Rosinha, II, WA1BXY and John C. Nery, WA1ESO received a certificate of appreciation from CQ for the 2017 World-Wide DX Contest CW. They received a round of applause.

Donald A. Rosinha, II, WA1BXY suggested that we form a new committee for supporting the antennas and radio equipment, which would branch away from the technical committee. Marcel L. Dumont, W1MLD explained that as President, he appoints special committees and oversees who is the chairman of each. He would be against this, sighting that too many committees would add unwanted convolution.

Robert B. Kelley, K1KVV and Raymond A. Arruda, KB1EVX officially announced that the SEMARA Flea Market will be held on Saturday, October 6, 2018. Setup will begin at 8:00 AM and buyers will be welcome beginning at 9:00 AM. The event will conclude at 12 noon and a VE exam session will be held inside the clubhouse at 10:30 AM. Door prizes were brought up for discussion and it was decided that we will not offer any. There was some discussion about ensuring that the exam session would be able to be held without interruption and a low noise level. It was noted that since we have not held a flea market in several years, there will be no admission fee in order to help attract the most amount of people.

David A. DeCosta, KD1YZ questioned if we ever considered blacktopping the driveway on club property. Marcel L. Dumont, W1MLD commented that it would be very expensive. Donald A. Rosinha, II, WA1BXY suggested reground which is half the price. Discussion followed, and it was suggested that if we did decide to go with a solution, we should at the least hard top the handicapped parking area. Marcel also noted that he would like to see the handicapped parking, which is currently between the clubhouse and the road, to be moved to near the new handicapped ramp. David agreed to try and get us a quote from an individual that paved his driveway.

Richard J. Cabral, W1RJC informed everyone that with the new Polycom IP phones in the clubhouse and the radio room, all calls to any phone number in the US or Canada regardless if it is local, local toll or long distance, you must always dial 1+ the area code, followed by the 7-digit phone number. Otherwise, the call cannot be completed as dialed. A laminated notification has also been posted above the clubhouse phone to these dialing instructions, plus to dial 9-1-1 in case of an emergency.
