Thursday, August 2, 2018

- **ARES, RACES, SKYWARN**

Krisnosky, Jr., N1IXC reported that the Massachusetts Emergency Management Agency (MEMA) Region 2, Sector A, Radio Amateur Civil Emergency Service (RACES) drill will be conducted this Monday, August 6, 2018. Joe also informed everyone that the MEMA Region II Headquarters located in Bridgewater has been shut down due to health concerns over a building issue. Due to this, it was unknown if they would be able to participate in this month's drill.

- **REPEATER**

Chairman Richard J. Cabral, W1RJC reported that there is an unidentified issue with the antenna system for the SEMARA APRS and 220 MHz repeater. As a result, both systems are temporarily off the air. About a month ago, Jeffrey J. Lehmann, N1ZZN alerted Rick that the APRS station was not reporting. Rick then also observed that the 220 MHz repeater was barely receivable about a mile away from the site. Since both the APRS and repeater are on the same antenna, there is a potential antenna issue. Rick shut down the 220 MHz repeater remotely and is still planning to investigate this when time allows. If it is the antenna, we will need to bring this to the attention of Al Costello of NETCOM.
