#### **NEW BUSINESS**

Robert B. Kelley, K1KVV made a motion which was seconded that we raise the amount to be awarded with our SEMARA Scholarship from \$500 to \$1,000. Discussion followed as to whether we want to award \$1,000 each year or biennially. The motion was then amended and seconded that we award the SEMARA Scholarship every other year in the amount of \$1,000. Discussion followed on an additional amendment to geographically restrict our offering. The motion was further amended and seconded to require that the applicant reside in Bristol, Plymouth or Barnstable counties of Massachusetts, with a restraint that their area of study be electronics/engineering. Discussion followed including the possibility to further require the applicant to be within a certain percentage of income. The amended motion carried with 2 opposed.

A motion was made, seconded and passed to reimburse for expenses. The expenses were \$39.44 for beverages and \$42.75 for miscellaneous/other.

Marcel L. Dumont, W1MLD discussed gutters for the clubhouse. He received an estimate of \$1,025. A motion was made, seconded and passed unanimously that we have them installed, including adding gutter guards at an added expense.

There was some discussion on the on 220 MHz repeater antenna. A motion was made, seconded and passed unanimously to purchase a brand-new NRG Comet CX333 antenna not to exceed \$200.

It was noted that a crane will be coming in October to change the antennas on the 80-foot tower. Help will be needed to assemble, and the date is yet to be determined. Discussion followed.

There was a discussion regarding the club's parking lot.
