Apparently some member(s) have been shutting it off despite a clear sign near the control forbidding this causing the temperature to drop below 60 degrees. Several remedies for this problem were discussed including a locked cover. It was decided that a programmable PIN would be incorporated to prevent tampering with the settings.
